Special Terms and Conditions for Lexmark Promotions (Reseller): “Lexmark X502n Promotion”

1. Scope of Promotion

By means of this Promotion Lexmark (Schweiz) AG, - Gewerbestr. 12, CH-8801 Thalwil (“Lexmark”), promotes the sale of Lexmark products as qualified in section 2 of these Terms and Conditions (“Product(s)”) by commercial resellers with its place of business in the territory of Switzerland (“Reseller(s)”) within a specific period of time as set out in section 3 of these Terms and Conditions. Lexmark authorised wholesalers are excluded from this Promotion. Lexmark authorised wholesalers are ALSO Schweiz AG, Meierhofstrasse 5, CH6032 Emmen / ActebisAG, Grossmatte 30, CH-6014 Littau / Ingram Micro GmbH, Brunnmatt 14, CH-6330 Cham.

Reseller will be awarded with 1 (one) GPS Fujitsu Siemens Loox N100 (“GPS”) per Product as qualified in section 2 of these Terms and Conditions which Reseller buys from a Lexmark authorised hardware-wholesaler in the territory of Switzerland or – if Reseller is registered as authorised Lexmark Partner by means of a Lexmark distribution agreement – directly from Lexmark.

2. Qualification of Products

The following Products are qualified for this Promotion:

3. Period of time

This Promotion applies to the Products qualified above that are purchased and invoiced by Lexmark authorised wholesaler in the territory of Switzerland or – if Reseller is registered as authorised Lexmark Partner by means of a Lexmark distribution agreement – directly by Lexmark – from June 1st, 2007 to July 31st, 2007.

4. Application Process for Promotion

To claim the GPS, Reseller shall fully complete the application form available at the Lexmark partner extranet www.partner.lexmark.ch and send the proof of purchase of Product in form of the related Lexmark authorised wholesaler’s invoice or an invoice by Lexmark – if Reseller is registered as authorised Lexmark Partner by means of a Lexmark distribution agreement in accordance with 1 (one) of the following alternatives:

- by scanning the invoice and attaching it to the on-line application form, or
- by fax at the number mentioned in the application form, or
- by mail at the address mentioned in the application form.

Reseller shall complete and submit the application form for this Promotion until August 15th, 2007 (exclusion period). Application forms which are improperly completed, incomplete or delayed in receipt will not be accepted by Lexmark.

If Reseller’s application for this Promotion is approved by Lexmark, a confirmation of the approval will be sent by email to Reseller.

5. Delivery Process for bonuses, awards and/or other sales assistance by Lexmark, shipping and passage of risk

The award will be shipped by DHL. The DHL tracking number will be communicated in the confirmation email so that the Reseller can follow the shipment of the award.

Risk passes to the Reseller upon delivery to the freight forwarder, carrier or any other person

Should any of the Products bought by Reseller be returned to the Lexmark authorised wholesaler for any reason, the award provided for the purchase of the returned Product must be returned by DHL at the following address:
